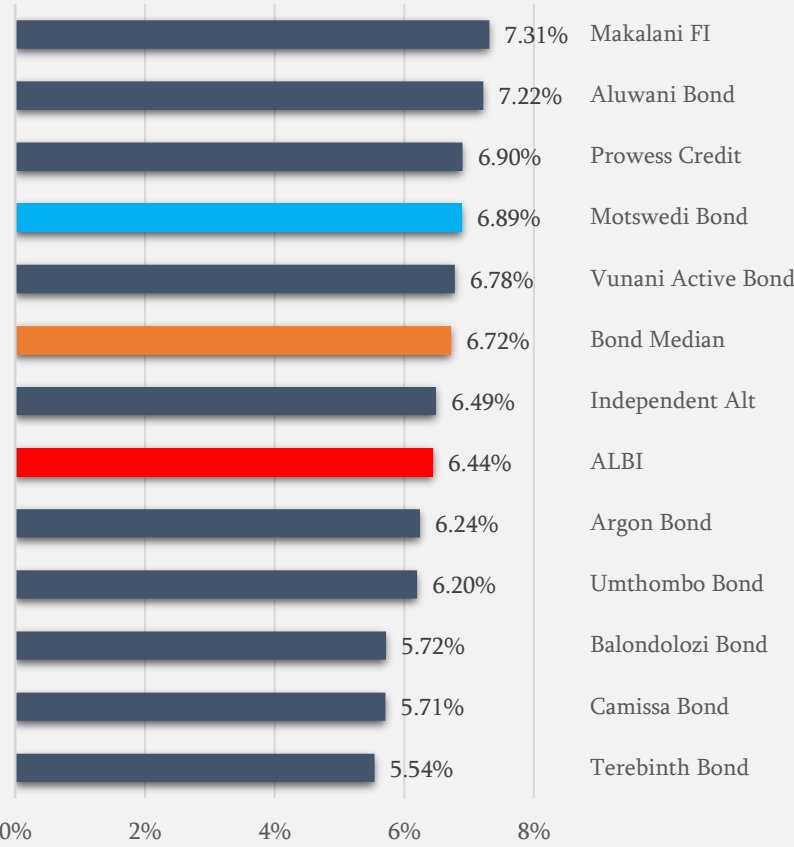

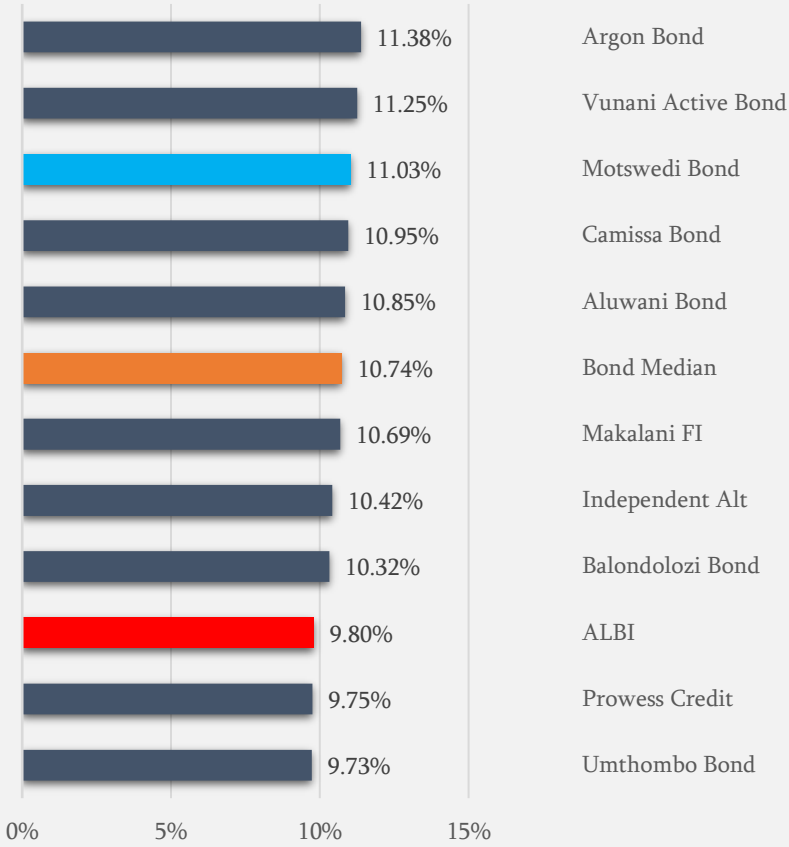

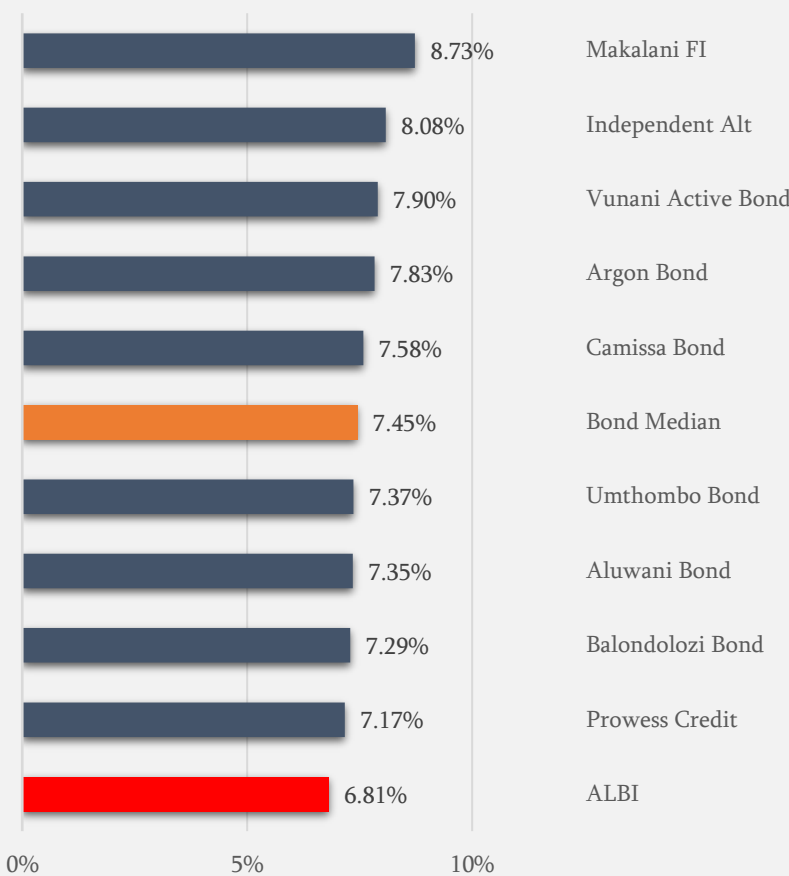
SA Bond

3 years to April 2023



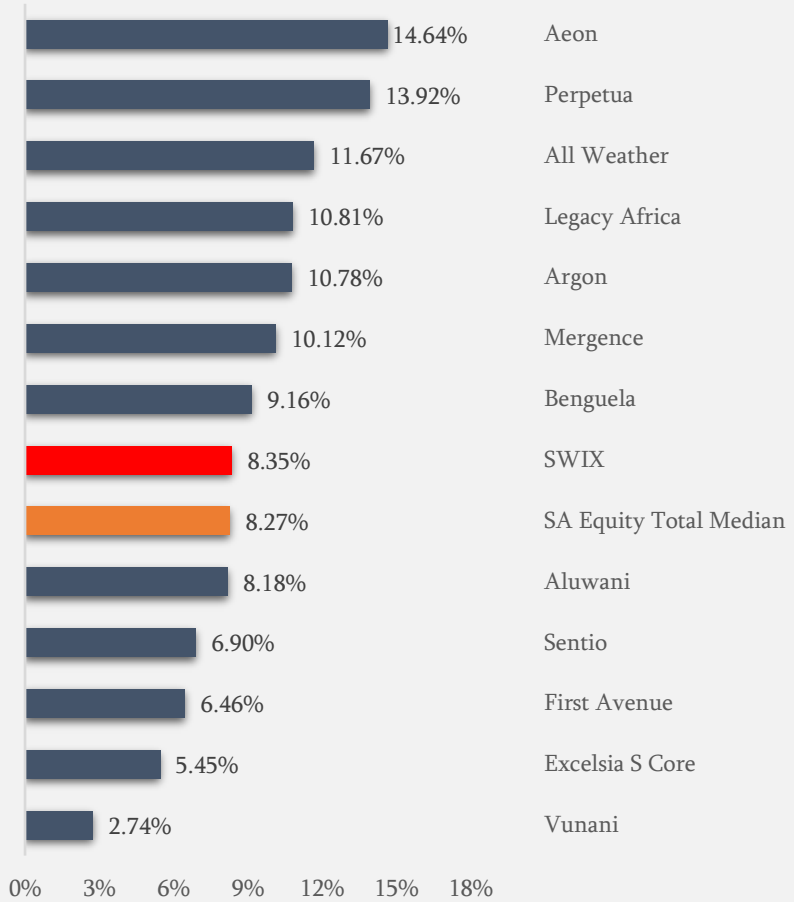

5 years to April 2023



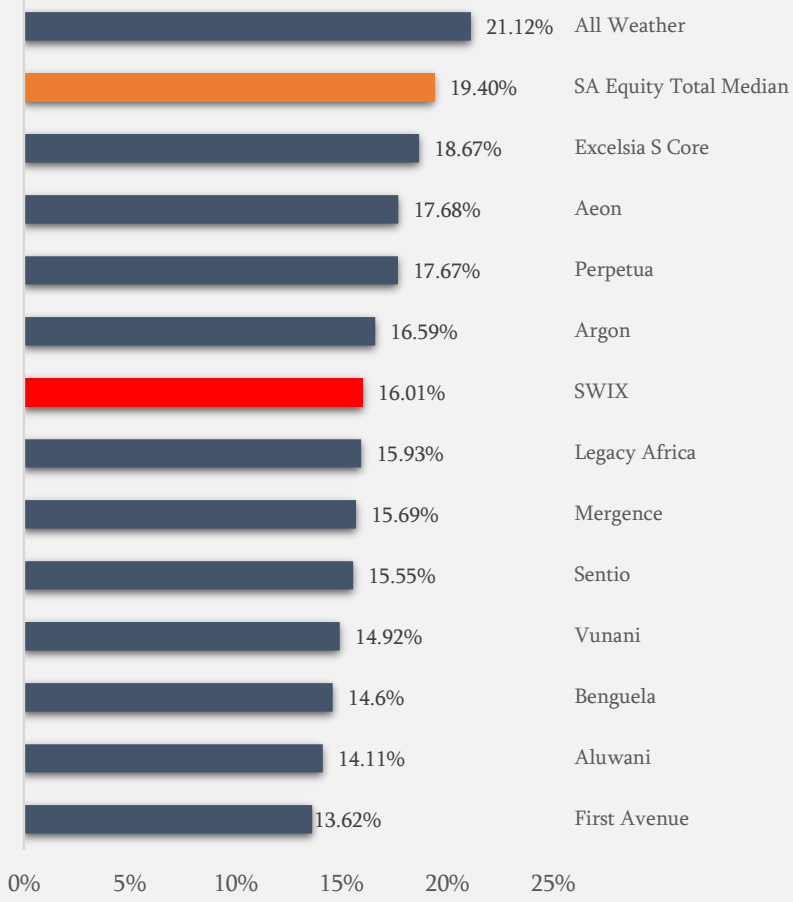

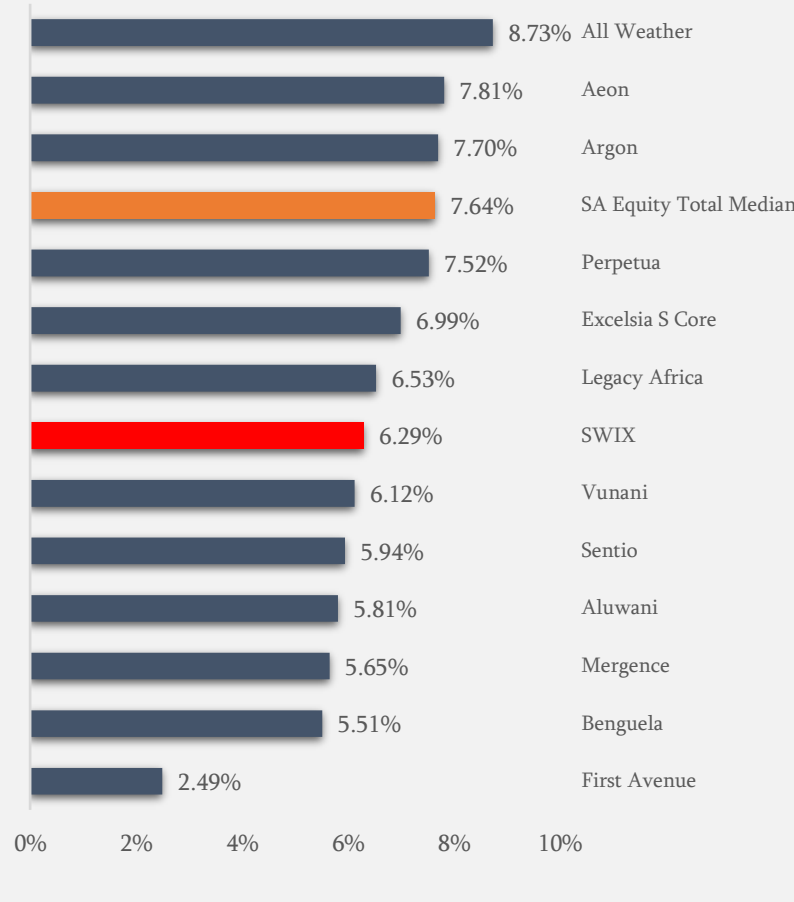

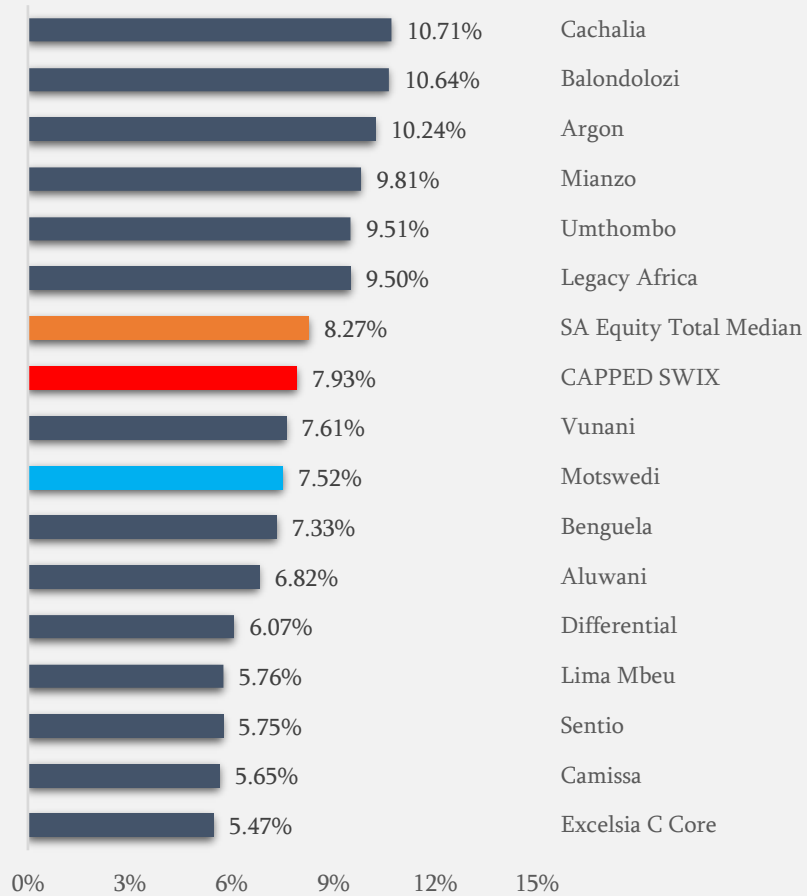

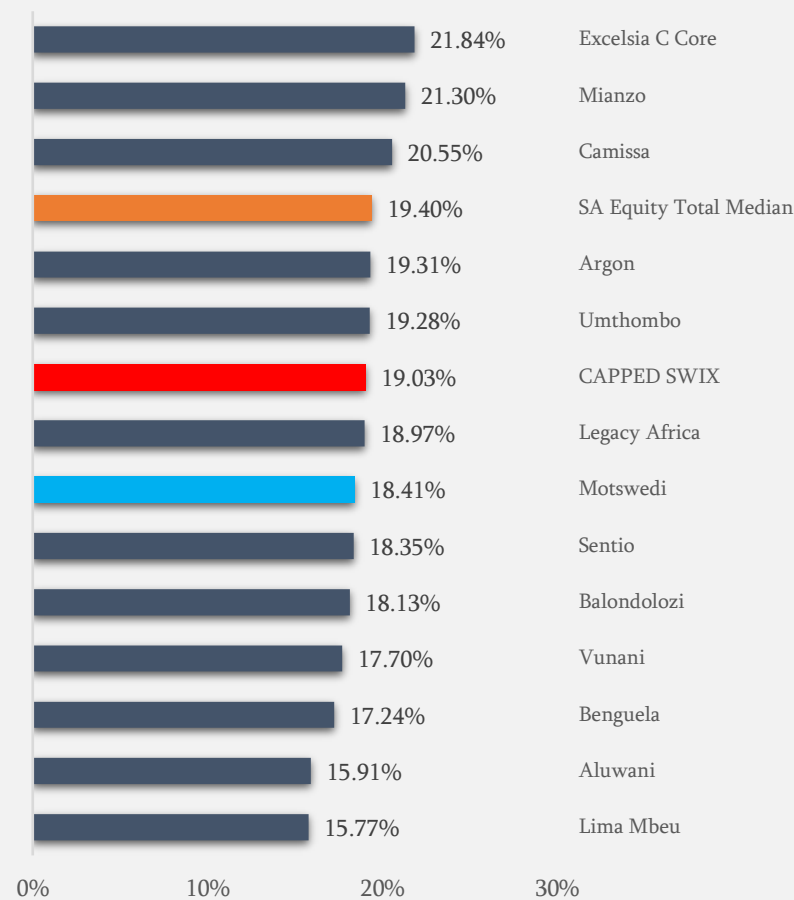

SA Equity - Capped SWIX

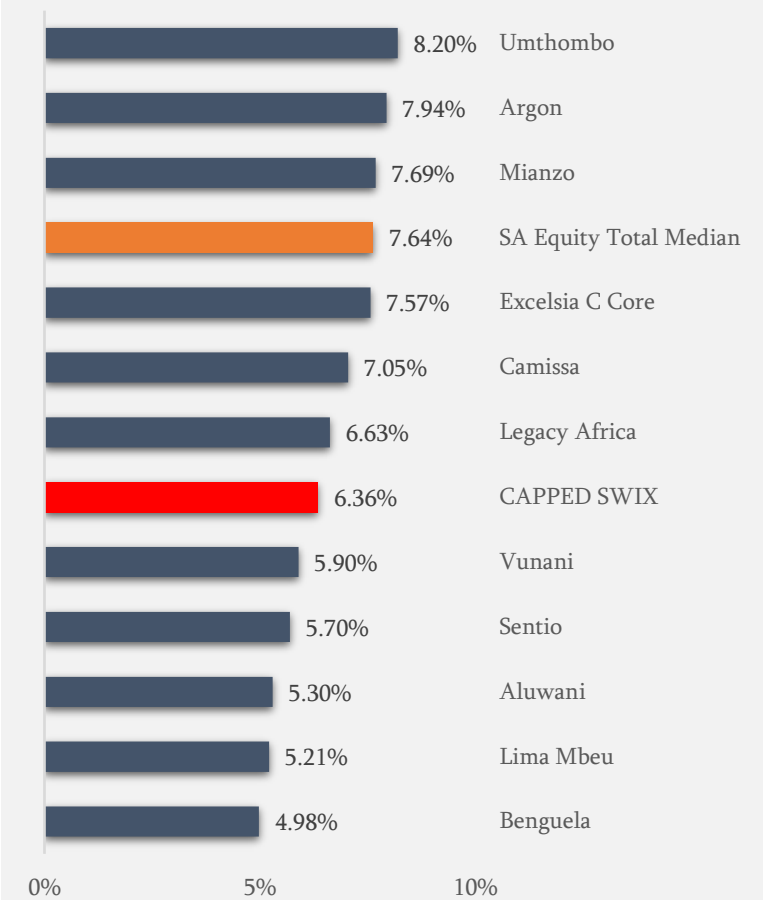

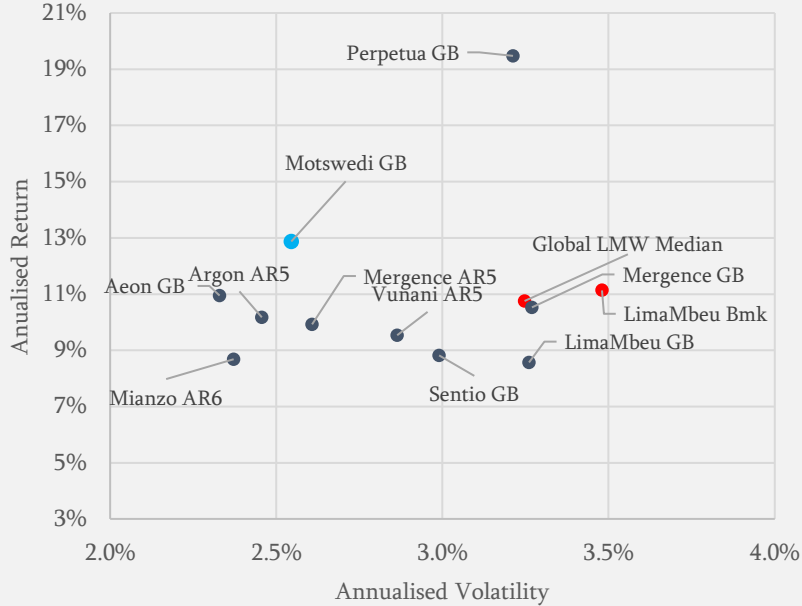

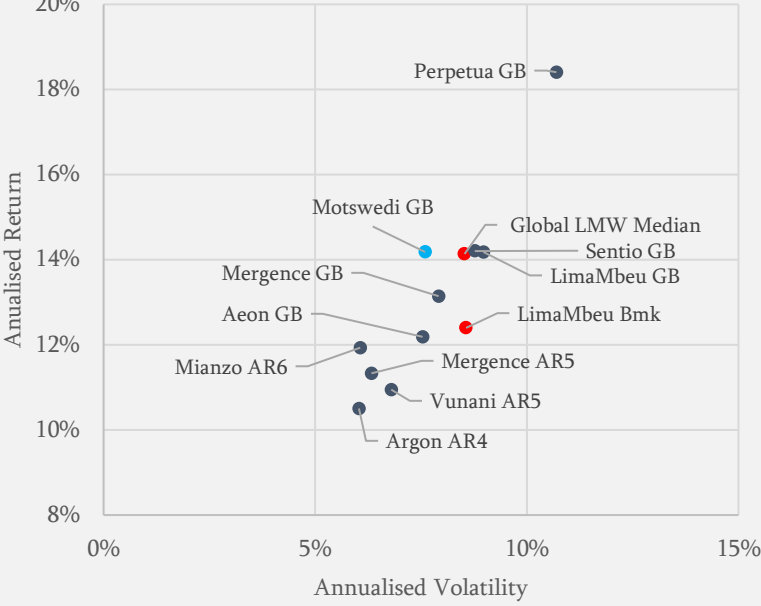

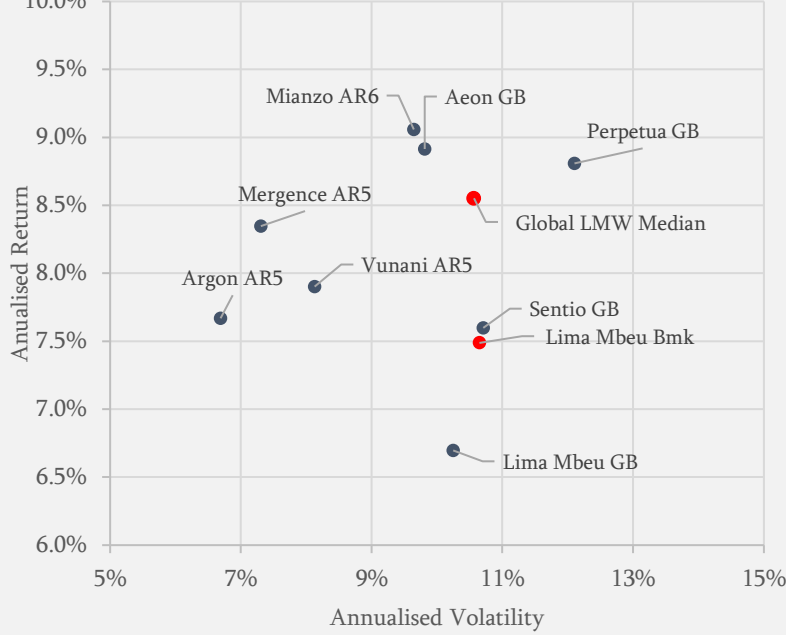
